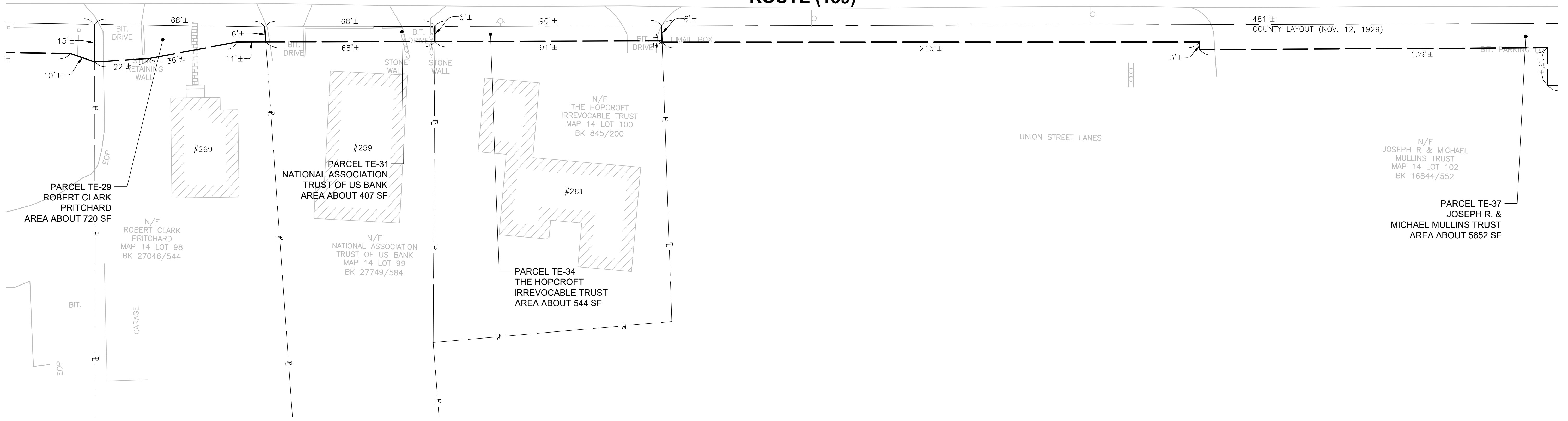


EASEMENT PLAN

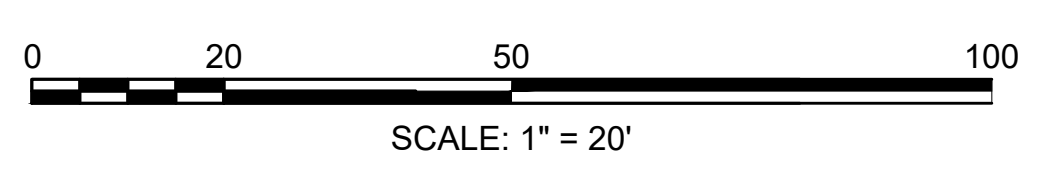

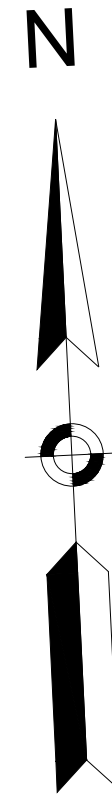

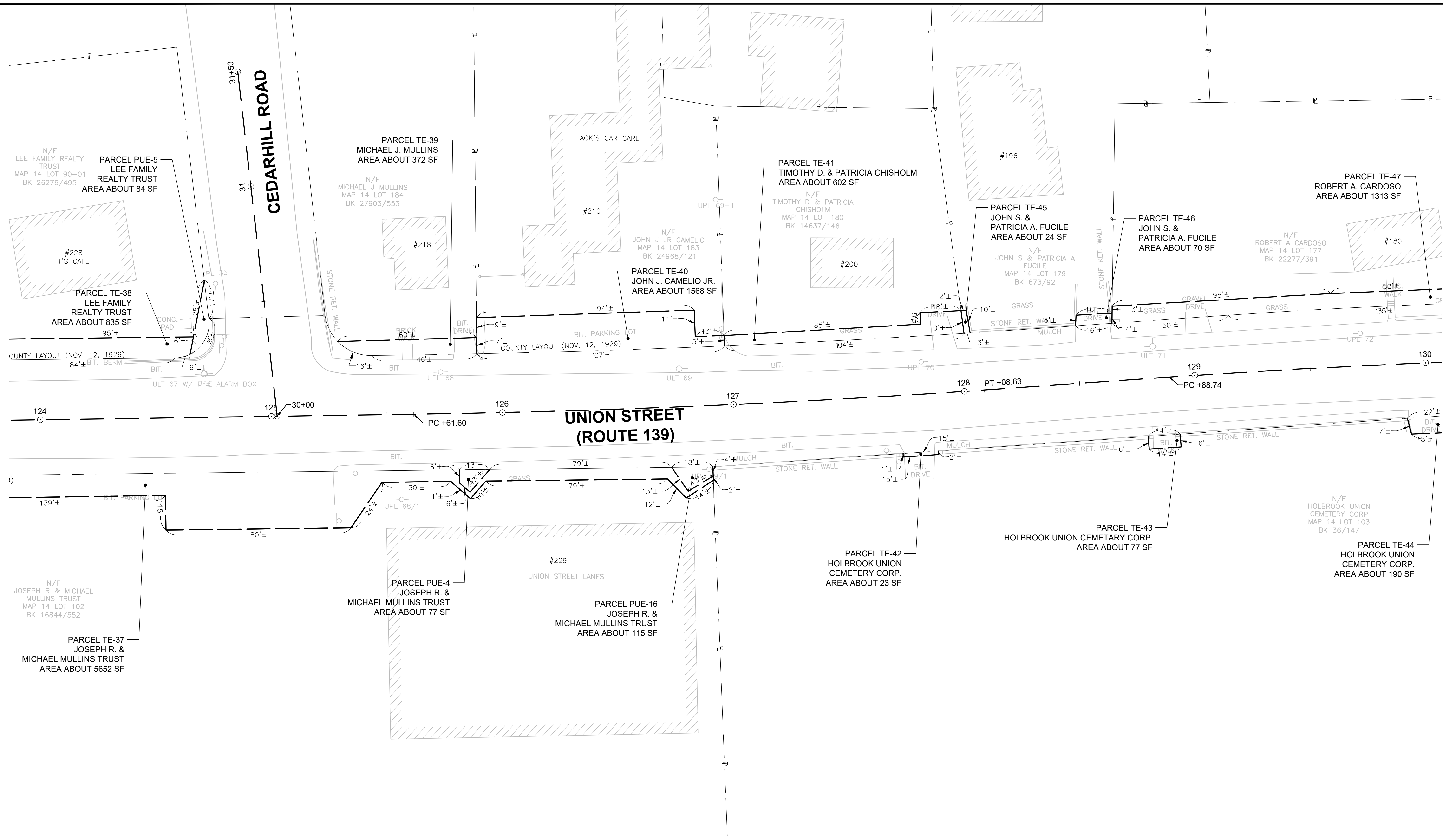
EASEMENT PLAN
