In Municipal Council 20.....

Ordered, That \$3,000,000 is appropriated to pay the cost of financing the construction, reconstruction, replacement, repair, and rehabilitation of sewers, and stormwater conveyance facilities, including without limitation sewer infiltration and inflow abatement improvements and pumping station upgrades for the purpose of eliminating unauthorized sewer connections to the City's drainage system, to eliminate combined sewer overflows and sanitary sewer overflows, to reduce infiltration and inflow within the City's sewer system, and to mitigate flooding resulting in potential surface water contamination; including the payment of all costs incidental or related thereto; that to meet this appropriation, the Treasurer with the approval of the Mayor is authorized to borrow \$3,000,000 under G.L. c. 44, §7(1), §8(14) or pursuant to any other enabling authority, and to issue bonds or notes of the City therefor; and that the Mayor is authorized to take any other action necessary or convenient to carry out this project. All or any portion of the borrowing authorized by this order may be obtained through the Massachusetts Clean Water Trust (the "Trust"), and in that regard, the Mayor and any other appropriate officials of the City are authorized to execute and deliver any and all agreements or certificates that the Trust may require in connection with any such borrowing.

Further Ordered, that any premium received by the City upon the sale of any bonds or notes approved by this order, less any such premium applied to the payment of the costs of issuance of such bonds or notes, may be applied to the payment of costs of the projects authorized by this order in accordance with G.L. c. 44, §20, thereby reducing the amount authorized to be borrowed to pay such costs by a like amount.
