WARRANTY COVENANTS, the land situate in the said Town of Lenox,

Beginning in the southerly line of Walker Street at the northeasterly corner of the land conveyed by Thomas Post and Edward McDonald to Louis H. Regnier by deed dated March 31, 1903 and recorded in Berkshire Middle District Registry of Deeds in Book 319, Page 484;

thence South 47° 26¹ 24" West a distance of 221.55 feet to an iron pipe set in a northeasterly line of land formerly of William B. Bull, now supposed to be of Roland H. and Judith H. Miller;

thence South 35° 15° 52" East a distance of 33.27 feet to an iron pipe set in said northeasterly line of land formerly of William B. Bull, at a corner thereof;

grantees and assigns, a roadway or driveway 33 feet in width, leading from the said land conveyed by Thomas Post and Edward McDonald to William B. Bull by their deed dated July 30, 1907 and recorded in said Registry of Deeds in Book 341, Page 220 to Walker Street, to use the water main and electric light main laid in said 33 feet wide strip as of July 30, 1907 and the right to lay and maintain a telephone conduit with wires in said 33 feet wide strip.

- 2. The right of Louis H. Regnier, his heirs and assigns, as set forth in a deed of Thomas Post and Edward McDonald to Louis H. Regnier by their deed dated January 1, 1910 and recorded in said Registry of Deeds in Book 353, Page 468.
- The right of Lenox Electric Company, its successors and assigns, as set forth in a deed of Thomas Post and Edward McDonald to it dated August 10, 1912 and recorded in said Registry of Deeds in Book 371, Page 64, to use the roadway or driveway, which runs from Walker Street southerly to the land conveyed by Thomas Post and Edward McDonald to William B.
