#### PARCEL 1

Beginning in the Westerly line of Cliffwood Street at the southeasterly corner of land of Jane A. Hill, now or formerly, at a white stone set for a bound;

Thence north 83 degrees west along the land of said Hill, 208.5 links to another white stone standing in the ground to mark an angle;

Thence north 80 degrees west still along land of said Hill, 224 links to another white stone in the line of land of said Hill set to mark the northwesterly corner of the premises being described.
