

PARCEL 1

Beginning at a metal nail set on the easterly side of Main Street and at the southwesterly corner of land now or formerly of Marino M. and Maureen E. Cimini;

thence in a general Easterly direction along the Southerly side of said Cimini 165.00 feet to an iron pipe set in the Northwesterly corner of Parcel 2;

thence in a general Southerly direction along the Westerly side of Parcel 2 and forming an interior angle of 90° 00' 00" with the last described course 101.16 feet to an iron pipe set in the Southwesterly corner of Parcel 2;

thence in a general Westerly direction and forming an interior angle of 90° 13' 22" with the last described course 42.74 feet to an iron rod set in the Easterly line of land now or formerly of Roger Weller;
