- 1. Provide survey notes (date of field survey, coordinate system/datum used, etc.)
- 2. Please provide size and material for all underground utilities (water, sewer, gas, drain).
- 3. Show connection between hydrant and water main and any gates.
- 4. Sewer manhole is shown on top of gas line.
- 5. Show lines to telephone manholes.
- 6. Where does CB to CB connection on John Mahar outlet?
- 7. Where does drain that goes through intersection outlet or connect to?
- 8. Show 48" CMP (culvert?) that is labeled on the plan on John Mahar and Show railing over the culvert
- 9. Missing some manholes at the intersection based on Google Street View.
- 10. Should OT MHs be Drain MHs?
- 11. Label layout number and year if available.
- 12. Add Z for Z parcels (adjacent parcels that have the same owner with book and page).
- 13. Connect Bank points on southwest corner.
- 14. Make sure to provide surface up to 20' off back of walk or wetland flags whichever closer. For example, missing contours on northeast corner (need bottom of the slope grade within 20' from bsw)
- 15. Check surface on south west side of John Mahar, just south of Point #4.
- 16. On Ivory Street there is a BEL handhole at the end of the sidewalk.
- 17. On Ivory Street there is a CB in front of the end of sidewalk.
- 18. Please provide invert information once it has been collected.
