## EXHIBIT "A"

All my right, title and interest in and to the land, with the buildings thereon, situated in Middleboro, Plymouth County, Massachusetts, on the Northeasterly side of Wareham Street, bounded and described as follows:

## LOT 1

Beginning at a stake to be set in the line of said Street, stake to be located 15 feet South 47 deg. 39' 50" East from a stone bound marking the South corner of Lot 10 on plan entitled "Plan of Lots, Barden Hill Terrace, Middleborough, Mass.", Surveyed for Ralph H. Caswell by Frederick S. Weston, C.E., Scale: 1"=60', 1922-1924" recorded with Plymouth County Registry of Deeds in Plan Book 3, Page 672;

thence from said stake North 42 deg. 20' 10" East 120 feet to a stake to be set;

thence North 2 deg. 5' 59" East 85.15 feet to a stake to be set;

thence North 42 deg. 20' 10" East 331.31 feet to a stake to be set;

thence in line of land formerly of Daniel H. Holmes about South 35 deg. West about 226.3 feet to a point;

thence in the same course about 43.2 feet;

thence in about the same course 140.53 feet;

thence about the same course by the bed of a stone wall 130.79 feet to a cement bound in the Easterly line of Wareham Street;

thence by said street North 47 deg. 39' 50" West about 160.46 feet to the stake first mentioned.

### LOT 2

Beginning at a point marking the Southwest corner of the lot of land conveyed to Phillip A. Nye by deed of Daniel H. Holmes recorded with Plymouth County Registry of Deeds, Book 1866, Page 24;

thence North 60 deg. West in line of said Nye land, believed now to be of the heirs of Howard Moody, 130 feet more or less, to a stake and stones marking an angle in the Easterly line of Lot 1 herein;

thence North about 35 deg. East in line of Lot 1 herein, 320 to a point in the Southerly line of a proposed road, as mentioned in the above deed from Holmes to Nye;

thence South 60 deg. East, along said proposed road, 140 feet more or less, to a corner of said Nye's land, now believed to be of Pittsley;

thence South 35 1/2 deg. West in line of land believed to be of Pittsley, 320 feet more or less, to the point of beginning.
