**DECLARATION OF HOMESTEAD**

Property address: 189 Wood Street  
Middleborough, MA.

KNOW ALL MEN BY THESE PRESENTS that I, LUCILLE M. GENTILE  
of 189 Wood Street, Middleborough,

County of Plymouth and Commonwealth of Massachusetts  
as a Householder, and having a family and being entitled to an Estate of Homestead in the land and build-  
ings hereinafter described do hereby declare that I own and am possessed and occupy said premises as a  
residence and homestead under Massachusetts General Laws, Chapter 188 as amended, to wit:

The land, together with the buildings thereon, situated on the Easterly side of Wood Street in  
Middleborough, Plymouth County, Massachusetts, bounded and described as follows:

Beginning at a gas pipe on the Southeast side of Wood Street;  
thence by Wood Street 72 feet to a gas pipe on the Southeast side of Wood Street;  
thence parallel with line of land now or formerly of Frank W. Hastay to line of land now or  
formerly of May E. Clark;  
thence beginning again at the first mentioned gas pipe;  
thence parallel with line of land now or formerly of Frank W. Hastay to line of land of said May  
E. Clark;  
thence in line of said Clark to intercept the first named parallel line.  
The first mentioned gas pipe is 290 feet from Frank W. Hastay corner as measured along Wood  
Street.

**Also**, another lot on the Easterly side of Wood Street, described as follows:

Beginning at a point on the Easterly side of Wood Street, being the Northwest corner of land now  
or formerly of Harrison Pepin and the Southwesterly corner of land conveyed;  
thence along the line of the land of said Harrison Pepin to the land now or formerly of George  
Clark, deceased;  
thence Northwesterly along said Clark's land to Wood Street;  
thence Southerly along the Easterly side of Wood Street to the point first mentioned.
