(4) has, in the opinion of the Association, ceased to to use its property for Unitarian Universalist

purposes; or
(5) has, in the opinion of the Association, failed to hold religious services with reasonable frequency.

A declaration approved by the Board of Trustees of Unitarian Universalist Association, or approved by the Executive Committee of said Board by not less than two-thirds of those present and voting, and duly recorded in the minutes of said Board or said Committee that the grantee is in default under the terms of paragraph (a) above, or has ceased to be active under paragraph (b) above and that no valid request for a release of the kind referred to in the paragraph below has been made, shall be conclusive evidence of such facts, and such declaration shall be binding upon the grantee and any party or parties claiming under or through the grantee when a copy of such a declaration, attested by the Secretary or Recording Secretary of said Association is recorded in the Registry of Deeds or other like office in which this deed is recorded.

Upon written request of the grantee, made at a time when there is no outstanding indebtedness of the grantee to the grantor whether or not then due and payable, and made at a time when any financial grants or aide given by the grantor to the grantee whether before or after the date of this instrument have been repaid, the grantor agrees it will release to the grantee any rights of reverter reserved in this instrument, provided that such release is not requested by the grantee at a time when the grantee is about to cease to be an active organization as that term is defined in (b) above.

VOTED: 1. That the Treasurer of the Association be and hereby is authorized and empowered on behalf of the Association, at any time when in his sole judgment he believes such action to be necessary or convenient in the conduct of the affairs of the Association and in its best interests, to do the following:

- (a) To execute, acknowledge, seal and deliver deeds or releases of parcels of real estate, used or to be used by Churches or Fellowships which are members of the Association, title to which stands of record in the Association, or with respect to which the Association is possessed of reversionary rights of any nature, whether by way of right of entry for condition broken or possibility of reverter, or otherwise; and
- (b) To convey or release such real estate or any interests therein to such person or persons, corporate or otherwise, by appropriate instruments in such form and containing such terms and provisions including, without limitation, a reservation of any such reversionary rights, as the Treasurer shall, in his absolute discretion, determine;
- 2. That the President, the Secretary and the Recording Secretary of the Association, or any of them, be and each of them is hereby authorized to join in the execution of any instrument executed by the Treasurer under the authority of this vote and that either the Secretary or the Recording Secretary be and each of them is hereby authorized to attest any such instrument.
- 3. That the execution of any such instrument by the Treasurer (whether or not other officers join in such execution) shall, for all purposes with respect to any person or persons relying upon or claiming under the same, constitute conclusive evidence that the Treasurer believes that the purposes intended to be accomplished by such instrument are necessary or convenient in the conduct of the affairs of the Association and in its best interests; that all terms and provisions in any such instrument set forth are satisfactory to the Treasurer; and that the person or persons to whom a conveyance is to be made is a proper party to the transaction involved.
- 4. That any person dealing with the Association may rely upon this vote which shall remain in full force and effect until a rescission or amendment thereof. The certificate of the Recording Secretary of the Association, bearing the seal of the Association and made a part of a copy of this vote, shall for all purposes constitute conclusive evidence that this vote is in full force and effect and has not been rescinded or amended.
