- For himself, his heirs, devisees and assigns, that the Town shall have access at all reasonable hours, to 4. said premises, to see that all laws, by-laws, ordinances, rules and regulations relating to the sewer are complied with.
- To notify the Town when the building sewer is ready for inspection. 5.
