- To notify the Town of Tewksbury when the building sewer is ready for inspection and connection to the public sewer, but before any portion of the work is covered.
- That construction of the sewer connection will be completed within sixty (60) days of issuance of this permit.

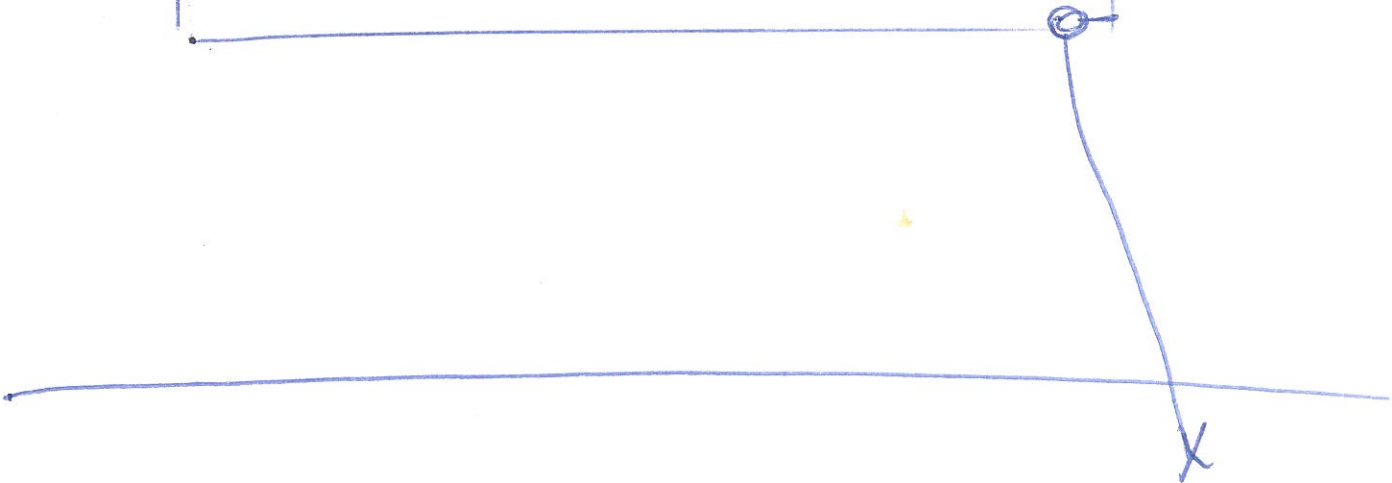
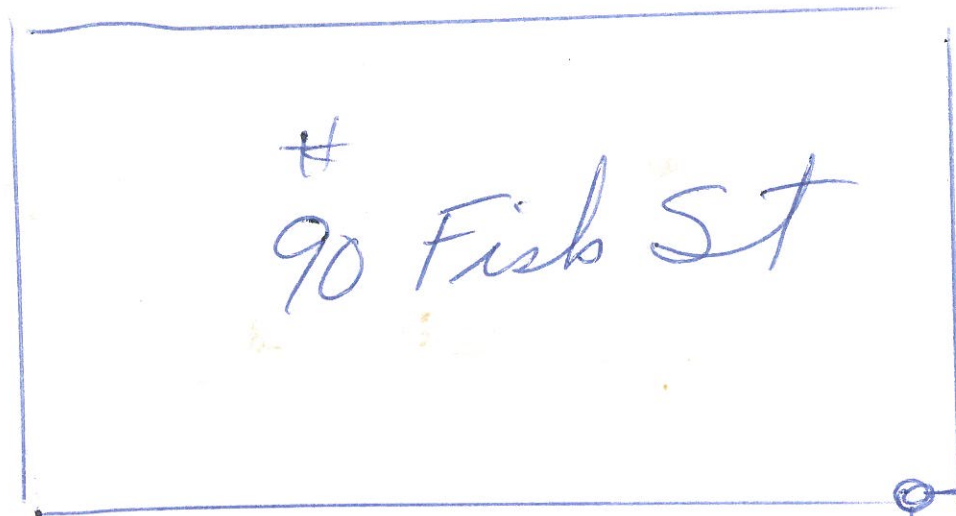

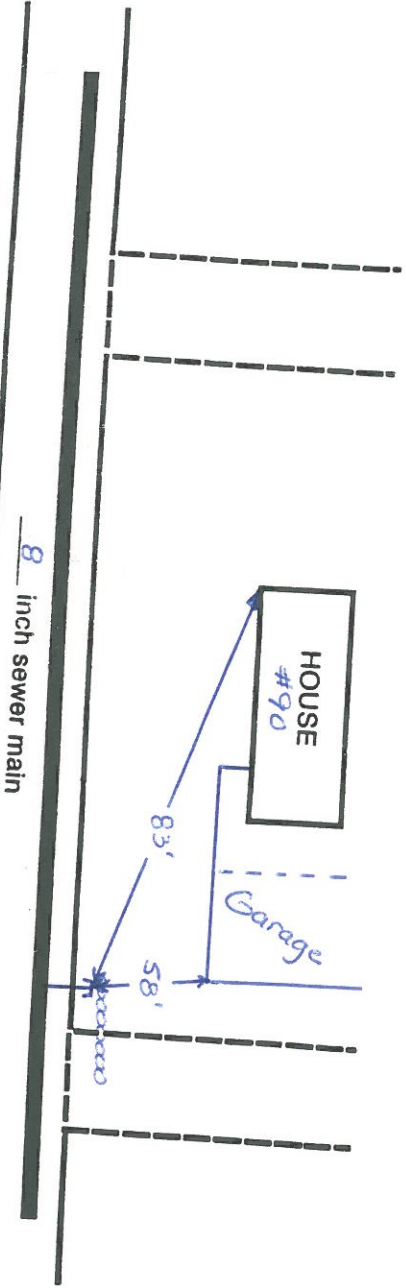
