- 4. For himself, his heirs, devisees and assigns, that the Town shall have access at all reasonable hours, to said premises, to see that all laws, by-laws, ordinances, rules and regulations relating to the sewer are complied with.
- 5. To notify the Town when the building sewer is ready for inspection and connection to the public sewer, but not before any portion of the work is covered.
- 6. That construction of the sewer connection will be completed within 60 days of issuance of this permit.

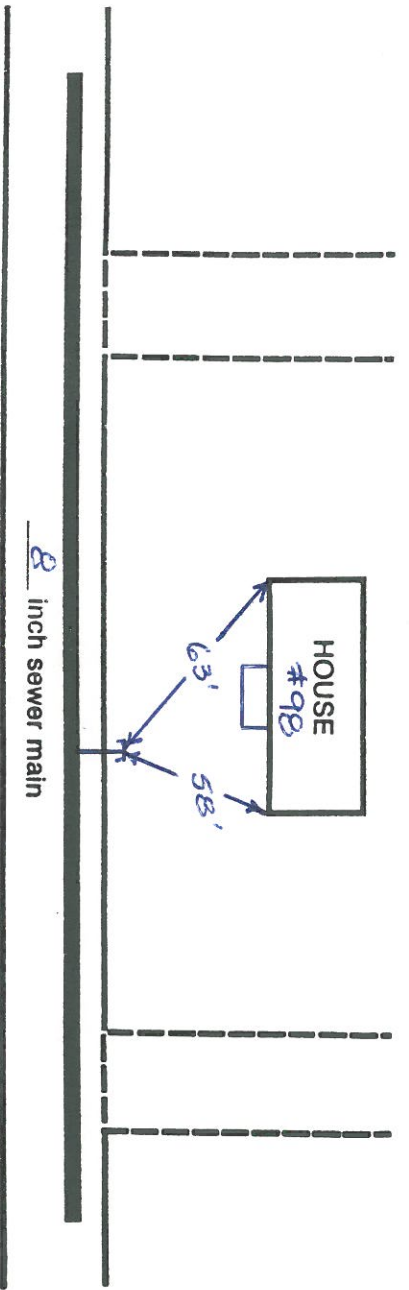
